Who we are?

In Control Scotland is an independent voluntary sector organisation which has now been operating for more than ten years. We work with and alongside health and social care partnerships, third sector and support organisations, people who use social services and their families.

Our focus is on helping to develop local capacity, knowledge, experience and belief to support people across the country to be in control and live independently with the support they choose.

Membership of **In Control Scotland** is open to all health and social care partnerships; third sector and support organisations and to individual people who support the movement towards full citizenship and independent living, whether, or not they have a direct involvement in the social care system.

Our work with Health & Social Care Partnerships focuses on:

- ♦ developing the local capacity, knowledge, experience and belief to support people to be in control and get more of the lives and support they want
- ♦ Sharing experience, tools, systems and practice that works
- ♦ Creating helpful connections between organisations and people

How will *your* Partnership benefit from annual membership?

There are two different levels of membership available to Health and Social Care Partnerships, **Associate** membership and **Full** membership

The benefits for both levels of membership include:

- ◆ Access to a community of learning and support comprised of the membership of **in Control Scotland**, with opportunities **to share and learn with others**, in regular **network** meetings, training events and/or topic based meetings
- ◆ Being the first to hear about the events, activity and resources developed through In **Control** Scotland. We provide up to date information and resources about people being in control and self-directed support, including regular newsletters, papers and briefings. You can tell us who you want from your Partnership on our mailing and contact lists.

In addition:

- ◆ As an **Associate** member, you have access to one day of support from In **Control** Scotland included in your membership, plus you will also receive a 5% discount on our standard rate for any further support, training or consultancy you may commission; and/or for any event we may organise that has an attendance fee
- ◆ As a **Full** member, you have access to four days of support from In **Control** Scotland included in your membership, plus you will receive a 10% discount on our standard rate for any further support, training or consultancy you may commission etc. This could include support to develop strategic and operational plans, training and awareness raising, developing a new resource allocation system, and/or implementing support planning and family and individual leadership. The support is provided by In **Control** Scotland Associates, utilising knowledge and experience from practice throughout the U.K and can be used to support change and development in adult and/or children's services.

How much does annual membership cost?

Membership rates for Health and Social Care Partnerships are as follows:

- ◆ **Associate** membership (including one day of direct support) - **£750**
- ◆ **Full** membership (including four days of direct support) - **£2,250**
